RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT

I accept for use AS IS the equipment listed on this form and accept full financial responsibility for the care of this equipment while it is in my possession. I will be responsible for the replacement, at full value, of any equipment rented under this form not returned to the AAIC rental agent. I agree to return all rental equipment by the agreed date or pay an additional rental fee for each day late.

I understand that backcountry travel (RECREATIONAL SNOW SPORTS) involve inherent and other risks of unintentional INJURY and DEATH. I voluntarily agree to expressly assume all risks of injury or death that may result from these RECREATIONAL SNOW SPORTS, or which relate in any way to the use of this equipment. I understand that each individual will be responsible for any injury he/she may sustain while using this equipment. Signing this contract signifies understanding that this document constitutes a release, which shall protect AAIC, partnering agencies, State of Alaska, our sponsors and all employees, volunteers and associates thereof. I AGREE TO RELEASE AND HOLD HARMLESS the AAIC, and the State of Alaska, sponsors and all employees, volunteers and associates including the equipment manufacturer and their successors in interest (collectively PROVIDERS), from all liability for injury, death, property loss and damage which results from the equipment user's participation in the RECREATIONAL SNOW SPORTS for which the equipment is provided, or which is related in any way to the use of this equipment, including all liability which results from the NEGLIGENCE of PROVIDERS, or any other person or cause.

I further agree to defend and indemnify PROVIDERS for any loss or damage, including any that results from claims or lawsuits for personal injury, death, and property loss and damage related in any way to the use of this equipment. This agreement is governed by the application law of the State of Alaska. For your safety, the Alaska Avalanche Information Center recommends training prior to using this equipment in the field.
